(2015-2017)

The ITI Tech Voting Guide serves as both a report card for members of Congress on key policy issues facing the technology sector, and as a reflection of ITI's legislative priorities for the 114th Congress (2015-2017).

House Vote Ratings for the 114th Congress

H.R. 1731, National Cybersecurity Protection Advancement Act of 2015: Legislation promoting increased cybersecurity threat information sharing both within the private sector and between the private sector and the federal government.

ITI's Position: Yea

As cyber threats continue to advance and evolve, the ability for the private sector to share information related to those threats within the private sector and with the federal government is critical for protecting individuals and U.S. businesses alike. H.R. 1731 provides for a voluntary, timely, multi-dimensional cyber threat information sharing system that shields network integrity while safeguarding personally identifiable information of online users and providing appropriate liability protections.

04/23/2015: Roll call vote #173, 355-63

H.R. 2048, USA FREEDOM Act: Legislation reforming U.S. surveillance programs to effectively end the indiscriminate bulk collection of data and allow for greater company transparency with their customers about government orders for data access.

ITI's Position: Yea

Intrusive domestic surveillance programs that corrode public trust in not only the government, but also the perceived independence of U.S. technology sector, are a threat to the open and borderless Internet upon which the innovation economy relies. By effectively ending the indiscriminate bulk collection of data, H.R. 2048 brings critical transparency to governmental data access and repairs consumer confidence in the privacy of their personal information.

05/13/2015: Roll call vote #224, 338-88

H.R. 880, American Research and Competitiveness Act of 2015: Legislation modernizing the tax code to both enhance and make permanent research and development (R&D) tax credits for U.S. companies to generate jobs and boost the economy.

ITI's Position: Yea

The R&D tax credit has a long track record of motivating U.S. investment, consumption, and exports; however, the lapse of these incentives over the years has discouraged the creation of new domestic industries and jobs. For U.S. companies to maintain their competitive edge in the international economy, there must be a tax environment that strongly promotes innovation. It is estimated that H.R. 880 would spur \$66 billion in annual economic growth and create at least 162,000 new jobs in the tech sector alone.

House Vote Ratings for the 114th Congress

H.R. 2146, Trade Promotion Authority (TPA) and Trade Adjustment Assistance (TAA): Legislation aimed at leveling the playing field of the global economy to ensure that U.S. companies can more easily sell technology goods and services to customers overseas, while stimulating impactful job growth at home.

ITI's Position: Yea

With 95 percent of the world's consumers living outside of the United States, in the new digital era it is imperative that companies can effectively transcend national borders to best reach, and serve, this expansive customer base. Obstacles that impede access to U.S. technology good and services, however, pose significant challenges to open markets and cross-border trade. H.R. 2146 represents a crucial step in achieving a more balanced and dynamic trading environment for U.S. companies overseas.

06/18/2015: Roll call vote #374, 218-208

H.R. 699, Email Privacy Act: Legislation updating the 1986 Electronic Communications and Privacy Act (ECPA) to require warrants for law enforcement access to online user data.

ITI's Position: Yea

Since the original passage of ECPA over thirty years ago, the Internet has fundamentally changed the way individuals communicate and participate in the global community. ITI believes that the privacy provisions protecting these communications should therefore reflect the current realities of the 21st Century, extending the same constitutional level of protection to online interactions as currently exist for those offline. H.R. 699 ensures that electronic communications older than 180 days would not be unjustly subject to warrantless government access.

S. 1890, Defend Trade Secrets Act of 2016: Legislation replacing the patchwork of state trade secret laws with a stronger, more cohesive federal law to better enforce intellectual property protections.

ITI's Position: Yea

The protection of intellectual property is a cornerstone of U.S. innovation because it drives competition to create the most forward-thinking, cutting-edge products, software, and solutions. Technology companies, who are the drivers of this innovation, rely on the protection of trade secrets that are the result of years of vanguard research investment. S. 1890 attempts to patch the existing gaps in federal trade secrets law and provide resources for trade secret owners at small and large companies alike to better protect their intellectual property from cyber criminals.
